**Public Forum**

There were two members of the public in attendance to address members of the Council about issues with speeding around the bends on the south entrance of the village and property damage as a result thereof. It was reported that there had been another accident with a tractor colliding into their neighbour's property the previous evening. The property is owned by Cllr Woodward. Cllr Arundell took ownership of this and raised an email to Lincolnshire Highways department requesting investigations into the provision of a crash barrier being erected at the corner.

**26/20 To Receive a Presentation of Fire Station statistics from Cllr A Arundell**
